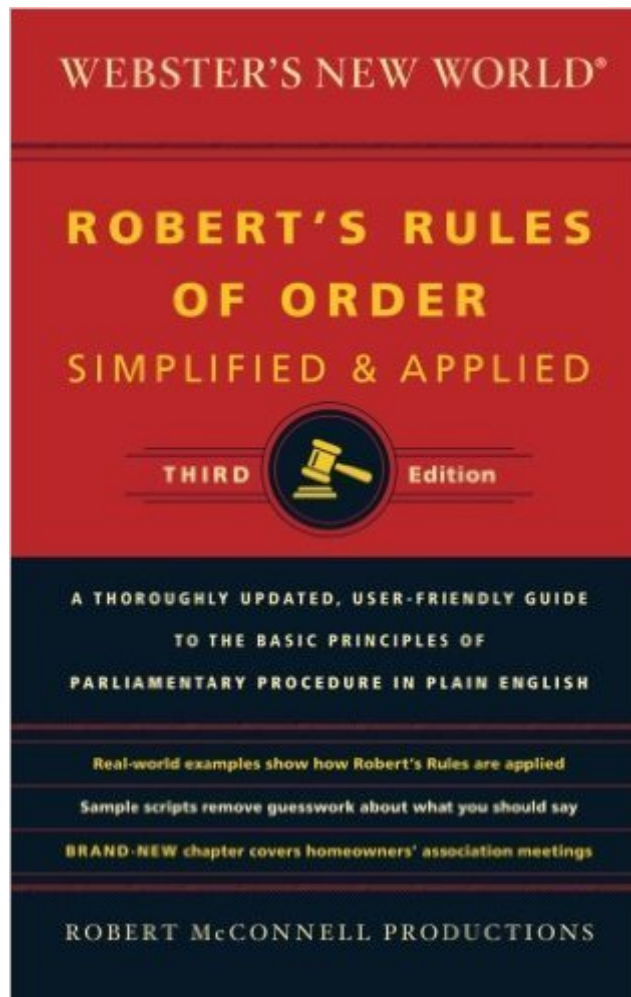

What makes this guide unique is that the author explains why procedures are important, and how, properly applied, Robert's Rules facilitate democratic leadership as well as efficient meetings. Also covers how to debate issues, handle unruly meeting attendees, and conduct elections. The third edition has added a chapter on using Robert's Rules in Homeowners' Associations (HOAs), with their somewhat unique organizational structure.
